**10:10**                    **Local Agency Data Collection (LADC)**  
**Donny McElveen & Emily Watts - SCDOT**

Local Agency Data Collection (LADC) is a process developed by SCDOT with the purpose of creating an updated and more accurate set of line data by combining data sets from the counties and SCDOT. Using specially developed spatial tools, we are able to use GIS software to match records from two data sets and move information from one to the other. This creates a more accurate line set for the DOT and allows counties to receive a more accurate proportion of funds based on the most up to date mileage and assist in collecting data required by MAP-21.

Donny McElveen has over 42 years of total service with the State of South Carolina, 40 of which have been with the South Carolina Department of Transportation. Mr. McElveen has managed the GIS/Mapping Office since 1999. As the manager of the GIS/Mapping Office, Donny has played an integral role in the development of many enterprise applications, including the Hurricane Evacuation System, the Roadway Information Management System (RIMS), the Integrated Transportation Management System (ITMS), Local Agency Data Collection (LADC), Planning Screening Tool (PST), Over Size Over Weight (OSOW) and the Statewide Mapping Project. He is also on the Geographic Information Council Technical Committee.

Emily Watts has over 4 years of experience in GIS and Mapping. She graduated from the University of South Carolina with a degree in Geography. Mrs. Watts then began working for South Carolina Department of Transportation (SCDOT) as a GIS Analyst in the GIS/Mapping Unit. During her time at SCDOT she has been involved with annexations, city and county maps, traffic flow data, external web site, HPMS, NHS, and LADC projects. Her main focus has been assisting in the development and testing of the LADC project.
